Local disabled veterans can benefit from 'No Barriers' program

Northeast Wyoming, just like the rest of rural America, is home to many men and women who have served in our armed forces. Some of them are living with a disability.

As part of Powder River Energy's strategic Purpose of improving the lives of those we serve, the Powder River Energy Foundation is endorsing an opportunity for free support of local veterans. One of PRECorp's capital financing insti-

tutions, CoBank, is affiliated with No Barriers USA. With this partnership, CoBank sponsors up to 50 rural veterans with disabilities to experience the No Barriers Warriors program.

Tina Fish of Crook County was a 2018 participant, the only one from Wyoming. Fish's 22 years of Army service has

It would have been much easier to forgo a moonshot and be satisfied with a more traditional goal such as keeping the cost of power in line with inflation, or reducing costs by some set percentage. Goals like that are pretty much "business as usual" and don't really drive transformational change.

The business as usual approach is not going to position us to be successful in the increasingly fast paced and ever-changing world around us. We made our mark on rural Wyoming 74 years ago when we began the process to electrify northeast Wyoming and our legacy of positively influencing and improving lives began.

In 1945 the idea of a "Moonshot" was not even conceived; that came with President John F Kennedy's declaration on September 12, 1962, to put a man on the moon.

However, I am confident that our founders would have considered delivering 300 megawatts of power over 11,300 miles of line across a 15,660 square mile area serving 26,700 meters of power an audacious and impossible goal. It was a huge Moonshot, and we did it.

Today's moonshot goal is no different in aspiration than that of our original founders. Imagine what things would look like if a major part of your monthly electric bill was on a declining trajectory. The costs to maintain and operate the powerlines and substations will still be there, but we are focusing on how to drive the costs down of the commodity portion of your monthly bill, and while we do this, we are also focusing on driving down costs in all areas of our business without sacrificing the safety and quality of service. This won't be easy, but that is even more reason to try.

In 2019 we are focusing on six strategic initiatives to help lay the foundation for our Moonshot journey. These initiatives impact culture, innovation, efficiency, rate design, technology, and education. The PRECorp team is excited and looking forward to working on these initiatives and beginning our journey to deliver amazing results, exceptional service, and lower costs to you, our consumer-members.

I look forward to next month and the opportunity to share more news about our strategic initiatives and how we are working to serve you.

In April, 'Thank a Lineman' like Dooley

Despite using the latest in safety gear and equipment, PRECorp's District Foreman in Wright, Justin Dooley and his wife of two years Heidi, are fully aware that he has one of the most dangerous jobs in America working as an electric lineman.

As we approach Lineman Appreciation Day on April 8, we ask that PRECorp members pause to say 'Thank you' to the power behind the power.

When Heidi met Justin, she admits that she was unaware of the importance of the role that linemen play in everyone's daily lives and how incredibly hard they work. "Every time you turn on your lights or heat your home a lineman is one of the people you have to thank for that," Heidi said. "A lineman will be out there day or night to make sure we are able to continue to do these things. We all should remember and be thankful that when this happens there is a lineman out there - rain, shine, or snow - working tirelessly to do whatever it takes to get the power back on for us."

Justin and his crew from Wright responded to at least a dozen outages in the first six weeks of 2019 in sub-zero temperatures and wind. "We always have extra clothes, food, and water, but when it comes down to it, you have to do what you have to do to get the power back on," he said. "There are times when you have to just get in the truck to warm up for 10 minutes, or trade with someone else to work on a pole."

But, Justin said, working safely is the number one thought on their minds. "The biggest concern I always have

is making sure everyone gets home with all their fingers and toes. We still have one of the most dangerous jobs in the U.S.," he said. "I had a very close friend and mentor tell me once: 'There are old linemen and there are bold linemen, but there are no old bold linemen.' You can never put a price on safety, and I will never ask someone to do what I wouldn't."

Heidi and Justin welcomed the bless-

ing of their beautiful baby daughter Harper Rae in January, adding a third member to the family. But, Heidi was already used to some sleepless nights thinking about her husband responding to outage calls.

"There are so many reasons for these [outage] calls including vehicle accidents, or the weather, and I never know what he might encounter. My thoughts are different when he gets called out on a warm summer afternoon, versus 2:30 in the morning during a February snowstorm. A lot of sleep is lost when I know my husband is out working in a blizzard in the middle of the night," she said. Many times, I find myself staying awake until I at least know he is on his way home. Whatever the reason, I can't help but worry, and I always pray for the safety of him and anyone else involved."

During April, PRECorp members are welcome to go to our Facebook page and let our linemen know you appreciate the hard work they do to keep the lights on, regardless of the conditions.





taken her to active duty in Korea, Germany, Saudi Arabia, and Kuwait. Her jobs ranged from heavy equipment operation, to Patriot Missile operator/tech, working as a 1SG.

“As a veteran there are things the civilian population does not ‘get,’” Fish explains. “We tend to bottle up those things. While at the No Barriers Warriors Basecamp, we had an opportunity to share these things in a confidential environment. That was therapeutic.”

Week-long expeditions take veterans to a challenging environment such as the Colorado Rocky Mountains or other public lands. Through successfully completing demanding activities like rafting, rock climbing and hiking, participants become better-equipped to overcome the obstacles they face in their daily lives. By sharing the experience with other veterans with disabilities, they also build a network of support that can last a lifetime.

Fish said the veterans in her group represented many decades of experience all the way back to the Vietnam era. “If you are physically able, I strongly encourage you to participate. We had an Air Force Veteran who lost his leg in a roadside bomb participate,” Fish added. “The purpose of the program is to encourage you to realize what’s inside of you is stronger than what’s in front of you. Meeting and working with a good cross section of individuals with many different disabilities was inspiring.”

CoBank’s sponsorship covers all associated costs for each veteran participant.

Combat-wounded or training-injured veterans (from any branch of service) with a VA disability rating are eligible for the program.





Be aware of scams

Scammers will try just about anything to trick PRE-Corp members into handing over money or personal financial information. Be aware that many scam calls will have the deceptive caller ID of Powder River Energy, and the voice on the line will claim to represent PRECorp.

They may threaten to shut off power unless a payment is made over the phone. Others may ask you to wire money from a local store. Some of the scammers will be very pleasant on the phone, while others may be quite rude.


Do not engage the scammer on the phone. Just hang up and give PRECorp a call.

Businesses are often targeted. The crooks try to take advantage of short staffs or the boss being away to pull off the scam. Notify your employees about the threat of scam calls on evenings, holidays, or weekends.

Remember, the only number you can trust to ensure secure account and billing management is 1-800-442-3630. If you receive a call saying your bill is unpaid or past due, call our toll free number.

Did You Know?

Powder River Energy has retired \$49.1 million to consumer-members since 2004 - \$8.4 million in 2018 alone. Because electric cooperatives operate at cost, any excess revenues (called margins) are allocated and retired to member-owners in the form of capital credits.



We clear certain areas in our service territory, known as rights of way, to:

- Keep power lines clear of tree limbs
- Restore power outages more quickly
- Reduce unexpected costs for repairs
