Outage stats stay positive

Over the past decade, PRECorp members have experienced a decreasing number of power outages, according to recent data from the cooperative’s System Operations team.


In 2019, PRECorp crews responded to 1,100 outages. PRECorp members, on average, were without power for about 198 minutes in total for 2019; that’s a little more than 3 1/3 hours per member for the entire year.

These numbers (see below) are a dramatic decrease from outage reports from 2009, which show 1,949 outages, leaving members more than 9.5 hours (573 min-

utes) without electricity for that year. The reliability improvement is a multi-year process of shoring up the power systems in the PRECorp service territory and leveraging technology to do a safer and faster job of restoring power when it does go out.

“We have been fortunate to have few high-impact weather outages,” said PRECorp VP of System Operations Rich Halloran. Halloran said line crews and design technicians are dedicated to detailed inspections and maintenance of all distribution lines and service drops, all the way up to large substations and high-volt-


Drive down costs so that the first megawatt hour of energy usage is at or near zero by 2050.

General Rate Case information update

Powder River Energy is seeking a 4.23% rate increase in a general rate case with the Wyoming Public Service Commission (PSC).

Changes affect residential and industrial classes. A PRE-Corp Residential member using the average amount of 1,175 kWh, will see an \$11.23 increase in their monthly bill, which includes a \$1.50 increase in the basic charge. The case is being filed in order to capture fixed costs being lost due to declining sales, and to bring the basic charge closer to cost of service.

PRECorp is seeking to change the billing of Residential Seasonal services, for example, stock well services, from annual to monthly billing. This change will take effect with the date of the rate change, September 1, 2020.

PRECorp is also filing to reintegrate much of the Coal Bed Methane (CBM) classes into General Service and Large Power classes in acknowledgement of less dedi-

cated use of system investments by CBM members.

The filing requests PSC approval and implementation in September 2020.



age transmission lines. “Crews also build to construction standards and apply avian protection in the work,” Halloran said.

In general, the power interruptions for members can be placed in one of two categories: controllable and uncontrollable.


Controllable outages are due to maintenance, construction, high-load moves, aging equipment, and danger trees. Controllable outages are down significantly from six years ago because of preventative maintenance programs and planning for grid redundancies for faster power restoration.

Uncontrollable outages are due to weather, animals, or damage by the public. Weather is by far the largest single threat to PRECorp lines. As a rural electric cooperative in northeast Wyoming, members are spread far and wide, with miles of line going through rugged countryside exposed to the harsh climate. In 2019 alone, the weather-caused outages rose by 8.4%. Plain and simple – there were more severe thunderstorms that damaged power lines and substations in 2019.

However, with that problem in mind, PRECorp is working to lessen the impact with advanced metering infrastructure or AMI. Over the next year or so, PRECorp is phasing in the installation of a system that can speed up the response and repair times for outages. The AMI creates a long-term communications network where individual meters can notify PRECorp System Operations of the location of an outage as it happens, which reduces analysis and response times.

Accidental damage to the system by animals and people are two other factors. PRECorp is a responsible citizen when it comes to protecting animal species from touching high-voltage power equipment. “We retrofit structures where bird contacts [or other animals] occur, as well as our new construction, to make them safe. Despite increasing populations of certain birds in our territory, incidents have decreased since 2013,” Halloran said.

In 2018, 41 animals caused outages. That number went down to 36 in 2019. In response, the cooperative installs additional protective devices on equipment animals are attracted to for food or shelter.



People are the most important priority when it comes to electrical safety. Human-caused outages outnumbered those caused by animals in 2019. Many were due to accidental contacts with poles, overhead or underground lines. Three motor vehicle accidents knocked out power in 2019. PRECorp regularly reminds the public of the dangers of overhead power lines, and our staff would gladly offer field safety demonstrations for any business or organization upon request.

This is all part of the PRECorp purpose of positively influencing and improving the lives for those we serve by providing reliable energy and services, while paving the way for access and affordability.



Deadline reminders for 2020 scholarships

Powder River Energy Corporation facilitates many scholarships for eligible high school and post-secondary students from northeast Wyoming.

To apply for any of the scholarships, students must satisfy the required criteria and complete the scholarship application. Updated 2020 scholarship information is available online at: www.precorp.coop//student-scholarships.

Descriptions and deadlines for some of the scholarships follow:

Swanda Scholarship - \$2,500

To a Crook County High School senior planning to enroll in agricultural or animal science studies at a university or vocational/technical school in Wyoming, North Dakota, or South Dakota. Seniors at Sundance High School receive preference this year on the program's rotating schedule. However, all seniors from Crook County are encouraged to apply.

The filing deadline for the Swanda Scholarship is February 28, 2020.

Powder River Energy Corporation/Foundation Scholarship - \$1,500

To qualifying seniors and post-secondary students from 14 high schools and up to 5 at-large students in its service territory. Applicant's parents or legal guardians must be active PRECorp members.

The deadline for Powder River Energy Corporation Scholarship is February 28, 2020.

Barb and Bill Geis Memorial Scholarship - \$400 to \$1,000

To qualifying seniors from Coal Country FFA or Gillette FFA in Campbell County, who are pursuing careers benefitting the agriculture industry. **The deadline for Barb and Bill Geis Memorial Scholarship is March 2, 2020.**

PRECorp Lineman Scholarship - \$3,000 and up

The PRECorp Lineman Scholarship is available to qualifying applicants who plan to attend an approved lineworker training program. Awards begin at \$3,000, but can be more. **There is no filing deadline and applications are accepted year-round.**

PRECorp marks 75 years of service in 2020
