The PRECorp 75th Annual Meeting will be one for the books! Given the current gathering limitations due to COVID-19, the Board carefully weighed out the pros and cons of hosting the annual meeting this year at their June meeting. The Board decided to move forward, but scaled down the event to ensure the optimum safety measures are observed as recommended by the Crook County Department of Health.

It unfortunately won't be the type of celebration we envisioned to mark PRECorp's 75th Anniversary. However, we hope the COVID-19 situation will allow us to at least conduct the business portion and director elections.

Additionally, the PRECorp Board is proposing to amend our Bylaws so that our election process can continue even if we are unable to establish a quorum of 100 members in attendance. PRECorp has used mail balloting in past years, but in order to use this as an alternative, it is necessary for a minimum of 100-members to participate using

the mail-in ballot system to hold an election. Therefore, all members are encouraged to vote using the mail-in ballot. By the time August rolls around, there's no telling what the meeting requirements may look like. Voting by mail will ensure your voice is heard no matter what.

This year we have two contested races, and I encourage you to read the candidate profiles carefully.

PRECorp Board President Walt Christensen will be stepping down from the Board. Having been elected as the Board President in 2011, Walt has held various positions over his 30-year tenure. Passionate about PRECorp, Walt has been a strong advocate for the "guy at the end of the line" during his many years of service. REPORT OF THE PRECORP BOARD SECRETARY/TREASURER

It is my pleasure to present to you the Treasurer's Report. As you will see in this report, the financial statements reflect the sound financial status of Powder River Energy Corporation (PRECorp). The PRECorp Board of Directors has examined the balance sheet and income statement for the year ended December 31, 2019, and review the Cooperative's financials on a monthly basis. The

accounting procedures and principles used by the cooperative are kept in accordance with the Rural Utilities Service's (RUS) standards, and are examined annually by independent audit. Complete versions of our annual audit, including the income statement and balance sheet, are on file at the Cooperative's office.

REPORT FROM THE CHIEF FINANCIAL AND ADMINISTRATION OFFICER

In 2019, PRECorp's total sales declined by 2.8%, after a decline of 4.1% in 2018. Total sales were sufficient to provide a positive operating margin at current rates. However, in December, PRECorp recognized \$895,000 from deferred revenue as part of the plan created in 2018. As PRECorp looks forward through 2020 and into 2021, focus is continuing to be placed on mitigating the impacts of bad debt and credit risk, implementing the 2019 rate case in September, managing risks and impacts of COVID-19 for its team and membership,

navigating through a declining sales environment, while at the same time focusing on operational efficiencies and strategies that have a positive impact on the Cooperative's financials. PRECorp strives to keep your rates predictable and stable, while maintaining a reliable distribution system and financially strong cooperative.

Notice of Bylaw Amendment

Notice is hereby given that the Powder River Energy Corporation Board of Directors will consider adoption of a bylaw amendment at 9:30 a.m. Tuesday, August 18. The bylaw amendment regarding Article III, Section 1, of the Corporation's bylaws is highlighted in RED below:

Annual Meeting

Article III, Section 1:

The annual meeting of the members shall be held in one of the counties of Campbell, Crook, Johnson, Sheridan or Weston, State of Wyoming, or at a location as may be designated in the notice of the meeting, and on the date established by the board of directors and designated in the notice of the meeting. The board of directors will post notice of the date designated for the annual meeting in the principal office of the Corporation not less than 60 days prior to the designated meeting date. The purpose of the meeting shall be the election of directors, passing upon reports for the previous year and transacting other business as may properly come before the meeting. It shall be the responsibility of the board of directors to make adequate plans and preparations for the annual meeting. Failure to hold the annual meeting at the designated time shall not work a forfeiture or dissolution of the Corporation. However the board may elect, in the event of exigent circumstances, to conduct an election without a meeting pursuant to Wyoming Statute §17-19-708.

Minutes of the 2019 Annual Meeting

UNAPPROVED MINUTES ANNUAL MEMBER MEETING HELD AT BUFFALO HIGH SCHOOL, BUFFALO, WY, AUGUST 24, 2019

CALL TO ORDER:

Board President Walter C. Christensen called the Annual Member Meeting to order at 1:35 p.m.

Christensen welcomed those present to the 74th Annual Member Meeting. Executive Staff Assistant Steph Pribilske was appointed as Recording Secretary.

RECOGNITION OF GUESTS:

CEO Mike Easley recognized the following attendees: Nominating Committee; Election Judges; PRECorp Board Directors, their spouses and families; PRECorp Foundation Board Directors; and Members 1st Directors and their spouses. Easley introduced special guests to the meeting which included Wyoming Senator John Barrasso who praised PRECorp for their commitment to the Membership and provided a brief State of the State address,

discussed the energy industry nationally and in Wyoming, and President Trump's efforts in these areas.

ANNOUNCEMENT OF A QUORUM:

General Counsel Mark Hughes announced that a quorum was present. Hughes then read the Notice and Order of Meeting.

APPROVAL OF MINUTES:

Christensen called for a motion to approve the 2018 Annual Meeting Minutes. A motion to approve the minutes as presented was made and seconded. Motion carried.

Christensen expressed his appreciation for the work of the Nominating Committee members and introduced the Director Candidates for 2020: Gerry Geis of Campbell County; Jim Purdy from Johnson County; and Reuben Ritthaler of Weston County.

Appreciation was also extended to the Election Judges. Christensen inquired if everyone present has voted. Hearing no objections, Christensen declared the voting closed and excused the Election Judges.

SECRETARY/TREASURER REPORT:

Secretary-Treasurer Gerald Geis reviewed the 2019 Treasurer's Report stating that PRECorp energy sales were at 2.18 billion kWh in 2019. This is a 4.1% decrease in kWh sold from 2017 to 2018.

Geis provided an overview of the year-todate financials, revenue deferral, purchased power, and a summary of operations. Geis discussed Capital Credits and how they play a part in other member benefits such as scholarships, and livestock sales.

PRESIDENT'S REPORT:

President Christensen extended his appreciation to the Board Directors for their commitment to the membership. Christensen also thanked the PRECorp employees for their efforts towards meeting the 2050 Moonshot challenge to drive down costs so that the first megawatt hour of energy usage is at or near zero by 2050.

FOUNDATION REPORT:

Jeff Bumgarner stated that 2019 has been a year of milestones for the foundation and highlighted three annual fundraising events – the Durham Ranch 10K/5K walk-run, the Lineman Scholarship Banquet, and the golf tournament. Bumgarner thanked the tireless efforts of the Foundation Board, sharing the loss of one of the founding Directors, Kathleen Tavegie. Her commitment and passion will be missed, but Bumgarner stated that it is only fitting that the Foundation met a financial milestone in her last year with us.

New to the Board is Michelle Edwards, Atlarge Director from Sheridan County.

Since its inception in 2007, the Foundation has donated \$1,017,308 to various organizations throughout the PRECorp service territory. The total financial community impact in 2018 was \$229,639 which supported 54 organizations and causes. Year-to-date giving in 2019 totaled \$101,605. While these number are substantial and continue to grow, the real milestone to celebrate this year occurred in June when the Foundation hit \$1 million dollars in funds donated.

Bumgarner reviewed some of the organizations that the Foundation has partnered with to support their efforts and impact in the community: the Wyoming Food Bank of the Rockies; Youth Emergency Services (YES) House; CORE Freshman Impact; YMCA's; and food banks, senior centers, and child services. The organization that helped the Foundation reach the \$1 million-dollar mark was Climb Wyoming – an organization that provides job and skill training and assistance to single mothers to help them become financially independent.

Bumgarner then introduced Gillette Program Director Jamie Marchetti from Climb Wyoming, and Foundation Board President John Flocchini. Bumgarner and Flocchini presented a check to Marchetti for \$5,000 in support of Climb Wyoming. Marchetti thanked the Foundation and membership for their support and shared program successes.

CEO REPORT:

CEO Easley conducted an informal poll inquiring whether nor not attendees have participated in a Town Hall - either by phone or FB, and who uses SmartHub. These are tools and new technologies that PRECorp uses to stay connected with the Membership. Recapping headlines from the CEO Reports of 2015, 2016 and 2017, Easley noted the common thread being the economy and its impact on the cost of power. During this time the PRE-Corp Vision Story emerged - a forward looking strategy laying the groundwork for the Moonshot. These strategies have also been detailed in the CEO WREN articles over the last year. Easley extended his gratitude to the PRECorp team for their help to develop the strategies to achieve the Moonshot - "Drive down costs so that the first megawatt hour of energy usage is at or near zero by 2050".

Easley reviewed a map detailing lightning strikes impacting PRECorp's system during

the past month and a historical graph detailing total minutes of outage time annually from 2014 to today. This illustrates the improved member service and response time to which PRECorp teams and systems have evolved.

In October 2019 PRECorp will be filing a request for a General Rate increase with an effective date of September 1, 2020. The requested rate increase will be an average of 4.4%, which will vary depending on the customer class. Easley stated that, despite the cost reductions and process improvements staff have implemented over the past couple of years, PRECorp is projected to have a \$1 million operating loss in 2019. Easley discussed Revenue Deferral, how it works, and how it has helped bring financial balance in lean years thus allowing PRECorp to stretch out time between rate increases.

Easley discussed changes in the coal mine industry and how PRECorp's new credit policy has helped to mitigate losses from the large load members. In the big picture, these members are important as they contribute to our overall purchased power and savings that result from these volumes – which benefits all members.

Easley reiterated that, while PRECorp has become a lean operation, there are has been no cutting corners on safety. Safety is PRECorp's number one priority.

PRECorp's strategy and vision has enabled us to remain hopeful and focused on the future. By being proactive, rather than reactive, we are ensuring our future.

UNFINISHED BUSINESS: There was no unfinished business.

NEW BUSINESS:

There was no new business.

ELECTION RESULTS:

Director Philip Habeck announced the results of the 2019 director elections. From Campbell County, Gerry Geis was re-elected; from Johnson County, Jim Purdy was re-elected; and from Weston County, Reuben Ritthaler was re-elected. There was a total of 386 votes received, 163 by mail, 223 in attendance. Director Habeck thanked the Election Judges for their commitment to PRECorp.

ADJOURNMENT:

With no further business the meeting adjourned at 2:45 p.m.

ALISON GEE
